Dear Friend and Supporter,

Welcome to Safe and Healthy Families, Sojourner's Gratitude Report. With this report, we are pleased to give you an overview of what your generous gift has accomplished. Your support reflects your commitment to transforming lives impacted by domestic violence.

In the 2016 fiscal year, the culmination of many donors, volunteers, and supporters working together helped us expand our critical work to serve more individuals and families impacted by family violence. More Milwaukee women, children, and men have hope because of your commitment to the community.

- More individuals and families are safely fleeing abuse.
- More survivors are healing physically and emotionally.
- More people have a path toward a secure and stable future.

Your gift is restoring hope to those who are hurting. In 2016, you were a beacon of hope for individuals calling the Sojourner 24-Hour Domestic Violence Hotline, which received 17,989 calls for help. Your support provided 16,994 nights of shelter to 307 women and 269 children escaping violence. Your outstanding dedication provided safety planning and assistance to 3,527 women and 999 men filing a restraining order

through our Courthouse Advocacy Program. You helped increase awareness in our community, as we conducted 170 community tours and held 1,898 meetings and events in our newly constructed Family Peace Center. Together, we provided safety, hope, and support to people impacted by family violence.

You gave, and thousands benefited. You helped us stand for human dignity. Our success was made possible with your help. We are thrilled to reach these milestones together, and we're amazed by the many foundations, corporations, donors, and volunteers who gave their time, talent and resources to make these milestones possible. During the past year, we continued to see a high demand for services. The urgency of domestic violence is still present. More than ever, we remain committed to providing seamless services to individuals in need, all under one roof. With your continued partnership, we can transform Milwaukee and create a community that is hopeful.

You Gave Lilly Hope

We first met Lilly when she reached out for help and had decided to open a criminal case against her abusive partner. A Sojourner Advocate, working closely with the Milwaukee County District Attorney's Office, met with Lilly, offered support, and discussed options. **Lilly was initially very upset and overwhelmed with all the decisions she faced after reaching out for help.** She had tried to leave her abusive partner several times in the past and was now feeling mixed emotions about getting law enforcement involved.

Lilly expressed many of her concerns to her Sojourner Advocate, and together they talked through these challenges and created a safety plan. The first immediate need was making sure Lilly and her son had a safe place to stay that night while her abuser was in custody. Additionally, Lilly was concerned about removing irreplaceable family heirlooms from the abuser's home. Our Sojourner Advocate provided a gas card that first day so Lilly could use her car to transport her personal items between her old and new home.

Lilly was also concerned about her son's wellbeing, so the Sojourner Advocate explained the role of the Milwaukee Public Schools Social Worker at the Family Peace Center, and gave Lilly the social worker's information as another resource. The social worker serves as a liaison between families and school personnel, and provided guidance to Lilly and her son's teachers on the impact of family violence and youth.

After mentioning that her son had recently exhibited behavioral changes, the Sojourner Advocate also connected Lilly to another co-located partner, Children's Hospital of Wisconsin Project Ujima, which provided social and emotional support, youth development and mentoring, and

mental health and medical services to her son and other youth impacted by domestic violence.

The Sojourner Advocate and Lilly also discussed staying at Sojourner Truth House 24-Hour crisis shelter as a temporary option, which offers a safe atmosphere for women and children fleeing a violent situation. Our shelter provides immediate needs, like food, transportation, clothing, security, children's programming, and counseling. Lilly considered staying at Sojourner Truth House after she moved her personal belongings from her abuser's home.

Throughout the intake, Lilly mentioned having a sore body and constant tension. Her Sojourner Advocate introduced our partnership with CORE/El Centro, a volunteer-driven organization that practices Chinese medicine, massage therapy, and holistic exercise to help individuals heal from trauma. Lilly was ecstatic to find out about the massages and other healing methods available, and after her Sojourner Advocate made a referral, was soon able to practice these methods of healing.

Now, Lilly feels a sense of calm and determination. **She and her son are now happy, feel safe, and are grateful for Sojourner's help.**

Your support enabled all of this to happen; you are restoring hope to those in need. You helped Lilly, and nearly 10,000 other women, children, and men who are living in violent homes across Milwaukee, have a safe place to sleep, resources and support to help them stabilize, and the skills needed to live independently.

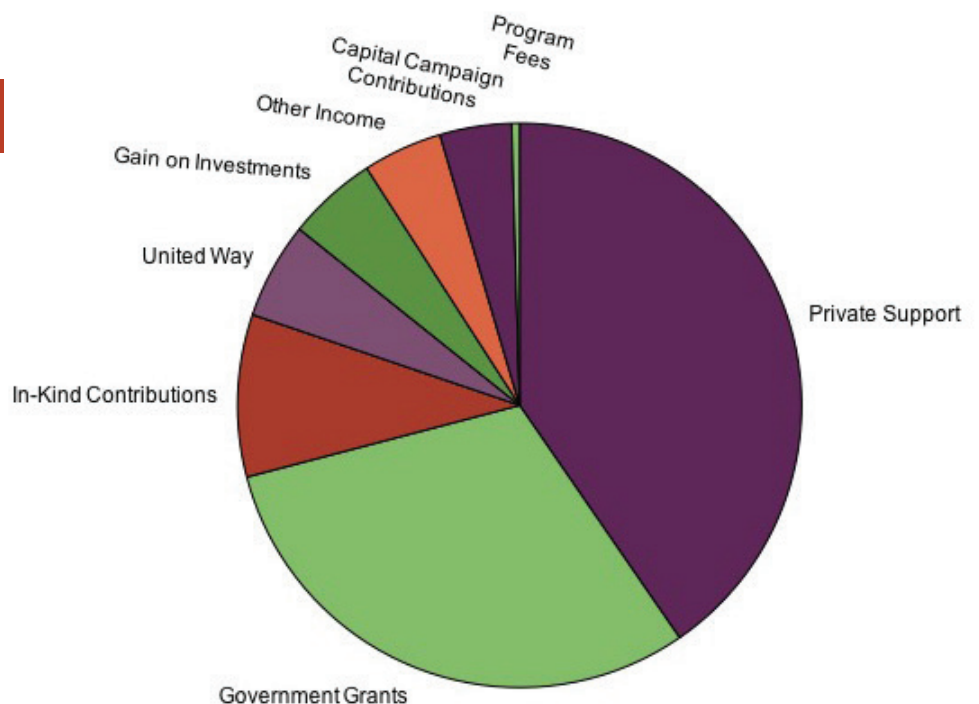
